Dear Attorney General Garland and Director Wray:

As you may know, Gun Owners of America, Inc. ("GOA") is one of the largest organizations in the nation representing and advocating on behalf of gun owners. We write to bring to your attention an important matter involving the FBI, resolution of which requires your involvement pursuant to federal statute.

In 2019, GOA became aware of the Federal Bureau of Investigation's ("FBI") use of a form entitled the "NICS Indices Self-Submission Form." This document (copy attached), created and in use by the FBI, purports to allow an individual to "voluntarily request permanent entry into the NICS Indices of the FBI's Criminal Justice Information Services (CJIS) Division's National Instant Criminal Background Check System (NICS)." Specifically, the form states: "I UNDERSTAND THAT COMPLETION AND SUBMISSION OF THIS FORM WILL RESULT IN DENIAL OF MY RIGHT TO PURCHASE, TO POSSESS AND TO USE ANY FIREARM."

The NICS Indices Self-Submission Form next requires an individual to certify: "I have a mental-health condition that may cause me to ... be a danger to myself or others" and/or "lack mental capacity adequately to contract or manage the details of my life." Paradoxically, after requiring a person to certify that he <u>lacks adequate mental capacity</u> to manage his affairs, the FBI form requires a "mental health professional" to certify that the very same person "has adequate mental capacity to voluntarily execute this document."

Once the FBI obtains a completed NICS Indices Self-Submission Form, the individual who signed it is reported to and entered into the FBI's NICS system as a "prohibited person" who is federally barred from acquiring or possessing a firearm anywhere in the country. Mere possession of a firearm by such a "prohibited person" constitutes a felony.

After learning of the existence of this FBI form, GOA submitted a Freedom of Information Act ("FOIA") request to the FBI in October, 2019 in order to obtain documents explaining the creation and use of the NICS Indices Self-Submission Form. In 2020, GOA was forced to file suit in U.S. District Court for the District of Columbia to compel disclosure of records in compliance with FOIA. Since then, based on documents produced, GOA has learned

that the FBI has utilized the NICS Indices Self-Submission Form on numerous occasions, to enter persons into the NICS system based on nothing more than an individual having signed the form.

Additionally, the investigative records provided to GOA by the FBI highlight concerns about how the form has been employed in practice to disarm American citizens. For example, the records which the FBI has produced to GOA show that the FBI has obtained signed NICS Indices Self-Submission Forms even though, in one case, the FBI agent "recommends closing this matter as this investigation yielded no nexus to terrorism" and, in another case, an "AUSA ... declined prosecution" of a subject who the FBI believed "does not appear to pose a threat to himself, others, or the President at this time."

More fundamentally, however, a person does not lose his Second Amendment rights to keep and bear arms simply because he signed a government form purporting to relinquish them. Indeed, there are reasons to believe that the FBI used this form to increase the number of prohibited persons on the NICS list, such as by "suggesting" that a person being interviewed should sign the form to close out an investigation. It is easy to see how signatures could be obtained in response to intimidation, threats, fear, or duress — eviscerating the purported consent required for any agreement to be effective.

Finally, and most importantly, the FBI has no statutory authority to create or to use such a form. The list of prohibited persons established by Congress, set out in 18 U.S.C. §§ 922 (d), (g) and (n), does not contain a prohibitor for a person who merely *self-reports* as mentally incapacitated. Rather, Sections 922(d)(4) and (g)(4) prohibit firearm possession only by someone who "has been *adjudicated* as a mental defective or has been *committed* to any mental institution." A person who signs an FBI form voluntarily has neither been "adjudicated" anything nor "committed" anywhere. Indeed, if such persons had met the Congressional test for "prohibited persons" under any other federal prohibitor, there would have been no need to coerce them into signing the form. Yet the FBI has been using the signing of its form as the sole basis to deprive Americans of their constitutional rights.

In other words, there no legal or constitutional basis for the FBI to have created or utilized the NICS Indices Self-Submission Form. Apparently, since Gun Owners of America shared our findings publicly, an FBI spokesperson told the *Daily Caller News Foundation* that the form was "discontinued" in December 2019.² Interestingly, this date corresponds to GOA's first public release of this form in *AmmoLand News*, also in December, 2019.³ Since that date, however, the FBI has yet to inform Gun Owners of America of this form's discontinuance, or of any corrective actions taken to rectify the situation or to restore the rights of those affected.

Past, present, or future use of this form conflicts with the statute that Congress enacted

and represents a clear infringement of Second Amendment rights that "shall not be infringed." Corrective action on your part is thus required and, indeed, is mandated by federal law.

As part of the NICS Improvement Amendments Act of 2007, 110 P.L. 180, Congress enacted 34 U.S.C. § 40901(e)(1)(D), which require "information updates" to the NICS system by the Attorney General and the FBI. Specifically, Section 40901(e)(1)(D)(i) states that a "Federal department or agency" which "provide[d] the pertinent information" is "made aware that the basis under which a record was made available ... does not apply," (emphasis added) the agency "shall ... remove the record from any database that the agency maintains and makes available to" NICS (emphasis added). Next, Section (e)(D)(ii) requires that the agency "shall ... notify the Attorney General that such basis no longer applies so that the National Instant Criminal Background Check System is kept up to date." Finally, the statute provides that "[t]he Attorney General upon receiving notice ... shall ensure that the record in the National Instant Criminal Background Check System is updated, corrected, modified, or removed within 30 days of receipt (emphasis added)."

Thus, pursuant to 34 U.S.C. § 40901(e)(1)(D), we hereby notify you, and thereby make you "aware" that the "basis" on which signers of the NICS Indices Self-Submission Form have been reported to NICS "does not apply." Thus, pursuant to you your duties under the statute, we respectfully request that the FBI: (i) identify and "remove" records from its "database" relating to those who have signed the FBI form; (ii) that the FBI (under the authority of the Attorney General) "remove" the offending records from the NICS system; and (iii) that the FBI halt its use of the illegal and unconstitutional NICS Indices Self-Submission Form.

Additionally, we request confirmation from your office that these statutorily required corrective actions have been taken within 30 days.
